# RACGP Standards for General Practices (5th edition) released

The Royal Australian College of General Practitioners (RACGP) Standards for General Practices (5th edition), have been released with the announcement stating they have been "developed with purpose of protecting patients from harm by improving the quality and safety of health services. The Standards also support general practices in identifying and addressing any gaps in their systems and processes."

The new Standards, Patient Feedback Guide and Resource Guide are now available at the RACGP website: <a href="https://www.racgp.org.au/your-practice/standards/standards-for-general-practices-(5th-edition)/">https://www.racgp.org.au/your-practice/standards/standards-for-general-practices-(5th-edition)/</a>.

From the launch date of 31 October 2018, practices can choose whether to seek accreditation under the 4th edition or the 5th edition of the Standards. From 1 November 2018, all practices seeking accreditation, will be assessed against the Standards (5th edition).

### Immunisation update

### Two-month-old childhood vaccines can be administered at six weeks

Due to the high morbidity and occasional mortality associated with pertussis in the first few months of life, the National Immunisation Program (NIP) now recommends providing the standard two month old vaccines as early as six weeks (effective July 2014).

Giving a first dose at six weeks of age rather than two months of age is estimated to prevent an additional eight per cent of infant pertussis cases. The next scheduled doses should still be given at four months and six months of age.

### Is it ok to vaccinate if child is slightly unwell?

Please be reminded that it is safe to administer vaccines in the case of a mild illness without fever (T <38.5°C).

There are only two absolute contraindications applicable to *all* vaccines:

- anaphylaxis following a previous dose of the relevant vaccine and,
- anaphylaxis following any component of the relevant vaccine.

### **Good news for Asylum Seekers**

Asylum seekers living in WA are now able to apply for a Safe Haven Enterprise Visa (SHEV). People who have arrived in Australia without valid travel documents can apply for this visa which will enable them to live in Australia for five years. People on SHEVs are eligible for Medicare services and trauma counselling services. SHEV recipients may present to their local GP requesting a health assessment or catch-up vaccination. They may have had a health check when they first entered Australia several years ago and may have some health records with them. It is recommended that all members of the family have their immunisations reviewed and are provided with catch-up vaccinations if required.

Since July 2017, all refugees and humanitarian entrants can have free catch up vaccines under the NIP. GPs and practice nurses are encouraged to assess the immunisation status of patients from refugee backgrounds, enter information into the Australian Immunisation Register (AIR) if it has not been recorded, and provide catch-up vaccines if required.

It is also recommended that all people under 35 years of age be considered for Latent Tuberculosis infection (LTBI) screening. SHEV recipients, who can easily travel to Perth, can have their LTBI screening and catch-up vaccines at the Humanitarian Entrant Health Service.

#### Report all Year 8 vaccinations via government procured vaccines form

The Australian Immunisation Register (AIR) has recently expanded to be a whole of life register, which will include the reporting of immunisations given to high school students from 2018. Until then, practitioners are reminded to ensure all vaccines administered to Year 8 students continue to be reported using the government procured vaccine form and submit this to the Communicable Disease Control Directorate (CDCD) for recording on the WA Health school-based immunisation program (SBIP).

### HealthPathways update

### **Cervical Screening**

HealthPathways WA has now reach **332** live pathways, with Cervical Screening the most recently published pathway. Cervical cancer is one of the most preventable cancers, with nearly all cases of cervical cancer caused by persistent infection with high-risk types of human papillomavirus (HPV).

There are approximately a dozen high-risk HPV types identified of which two (HPV 16 & 18) have been found to cause 70 - 80% of invasive cervical cancer.

Since the introduction of the National Cervical Screening Program (NCSP) there have been significant reductions in the incidence of cervical cancer and mortality. A further reduction is expected with the implementation of the renewed NCSP scheduled for 1 December 2017.

The pathway is available on the live HealthPathways WA site, and will also be utilised by other HealthPathways regions in Australia. It includes information and recommendations about the Cervical Screening Test; the management of women with special circumstances; women who are transitioning to the new program; self-collection criteria; and contains links to resources and information sheets for both healthcare professionals and patients.

### **Expert Health Panel for PFAS**

The Department of Health has established an Expert Health Panel for Per- and Poly-fluoroalkyl Substances (PFAS) to advise the Australian Government on the potential health impacts associated with PFAS exposure and to identify priority areas for further research. To achieve its objective, the Expert Health Panel will consider the evidence available from both Australian and international scientific research into the potential human health effects of PFAS exposure, and consider the views of the public and other stakeholders through an invitation for public written submissions.

The Expert Health Panel is now inviting submissions to better understand the range of public views on the potential health impacts of PFAS contamination and what the focus of future research should be. Allen + Clarke has been engaged by the Department of Health to conduct the public consultation and report the findings back to the Expert Health Panel.
