## Transition of the Australian General Practice Training Program

Services Australia - Registration for support payments

Information for Practices, Supervisors and Registrars

**It's time to register for Training Support Payments!**

### **Note:**

- *Services Australia's payment system identifies the Australian General Practice Training (AGPT) program as "the General Practice Training Program (GPTP)". All participating practices, supervisors and registrars should note the AGPT program is the same as the GPTP on the Services Australia's payment system.*
- *All participating practices, supervisors and registrars will need to come back to enter their banking details on the payment system from December 2022.*

### Background

As part of the transition of the AGPT program, training support payments will be paid through a Services Australia payment system. The new support payments will commence from semester 1 2023. The new support payments will be available to accredited training practices, supervisors and registrars.

## Practices: What Do You Need To Do?

For **accredited practices** to receive support payments through the new payment system you will need to:

1. Register for an Individual PRODA account **and Organisation PRODA account**.
2. Register on the **Organisation Register**.
3. Enter your **banking details on the Organisation Register from December 2022** so that payments can be made to you through the payment system from early 2023. We will let you know when you are able to supply banking details and provide you with support material.

## Things you need to know

- **You need to have the above registration steps in place to get training payments from semester 1 in 2023.**
- Please see schedule for registering below. However, if you have missed your week, you can still register and you don't need to wait until your week to register if you are ready to set up now.
- If you have practices in multiple states you can register all at the same time.
- Even if you already have a PRODA account set up, you will still need to register the **Organisation Register** for this program
- If you will be receiving supervisor payments, your supervisors do not need to be registered in the Organisation Register.
- If you would like your College (RAGCP or ACCRM) to pay your supervisor directly, your supervisors will need to have an individual PRODA account linked to HPOS. More information for Supervisors is listed below.

<b>17 – 23 October 2022</b> <b>Commenced</b>	Tasmania and Eastern Victoria (EVGPT)
<b>24 – 30 October 2022</b> <b>Commenced</b>	Western Victoria (MCCC)
<b>31 October – 7 November 2022</b>	North Queensland (JCU)
<b>7 – 13 November 2022</b>	Northern Territory and South Australia
<b>14 – 20 November 2022</b>	West New South Wales

<b>21 – 27 November 2022</b>	North East New South Wales
<b>28 November – 4 December 2022</b>	South East New South Wales

## Supervisors: What Do You Need To Do?

For **supervisors** to receive support payments through the new payment system you will need to:

- Talk to your practice to work out how payments will be made to you.
- If payments are being made to the practice and then paid to you, there is no action required from you.
- If payments are to be made directly to you, you will need to follow the steps in the table below.
- Enter your **banking details in HPOS from December 2022** so that payments can be made to you through the payment system from early 2023. We will let you know when you are able to supply banking details and provide you with support material.
