

Access to Digital Health Tools and Online Provider Services

The Health Identifier Service, PRODA and HPOS

Overview

Government digital health tools and services, including My Health Record (MHR), are managed in the **Health Professional Online Service (HPOS)**, accessed through **Provider Digital Access (PRODA)**. Data linking and secure encryption are made possible through **Health Identifiers (HI)** and **National Authentication Service for Health (NASH) Public Key Infrastructure (PKI) certificates**.

What are Healthcare Identifiers?

Healthcare identifiers (HI), managed by the Health Identifiers Service (HI Service), form part of the national infrastructure needed to support the safe and secure use of digital health tools such as My Health Record, secure messaging, and electronic prescribing. There are three types of healthcare identifiers:

- **Individual Healthcare Identifier (IHI) - for individuals receiving healthcare services.** This number is automatically allocated by Medicare to all Medicare or DVA card holders. Non-card holder can [request an IHI from Services Australia](#).
- **Healthcare Provider Identifier – Individual (HPI-I) - for healthcare providers.** Medicare allocates an HPI-I number to all AHPRA registrants. Health professionals not covered by AHPRA can [register for an HPI-I from Services Australia](#) directly. Linking your HPI-I number in HPOS will give you access to the provider programs and functions relevant to your role.
- **Healthcare Provider Identifier – Organisation (HPI-O) - for organisations that deliver healthcare** such as general practice, allied health clinics, hospitals and diagnostic services. HPI-Os can be allocated to organisations and sole-traders providing healthcare services by application via HPOS. HPI-Os are assigned separately for seed (parent) and network (child) organisations.

When applying for an HPI-O, there are two key roles required to support the application and ongoing maintenance of the organisation:

- **Responsible Officer (RO)** – an individual with either direct or delegated authority to act on behalf of the business. This may be an owner, CEO or a nominated member of the team
- **Organisational Maintenance Officer (OMO)** – An individual responsible for the day-to-day administration of the organisations Health Identifiers and My Health Record. More than one OMO can be setup and can also be registered as RO.

What is PRODA?

Provider Digital Access (PRODA) is an online identity verification and authentication system. It functions as a provider version of MyGov, providing secure access through a single portal to government online provider services. PRODA accounts are linked to an individual, not to an organisation, allowing the same account to be used in multiple roles. What is HPOS?

Health Professional Online Service (HPOS) is a simple and secure way for eligible providers or organisations to do business with Services Australia. See the [fact sheet](#) for more information on what you can do with HPOS.

What are NASH Certificates?

National Authentication Service for Health (NASH) is a Public Key Infrastructure (PKI) solution enabling healthcare provider organisations to securely access the HI Service, My Health Record, electronic prescribing and secure messaging. NASH PKI certificates are requested through HPOS and installed to the clinical software. Certificates must be renewed every two years.

Practices may contract an organisation that provides technology services or health information management services, known as a Contracted Service Provider (CSP), to act on their behalf. Access to the HI Service and/or My Health Record system is provided by the CSP software using the CSP's own HI and/or NASH certificate. Practices must link the CSP to their organisation in HPOS.

How to set up provider access to health provider services and the health identifier service

To set up access to the health identifier and health provider services, the following steps need to be considered:

- Capability and system compatibility
- Ensuring compliance with legislation
- Setting up access
 - Create an individual PRODA login
 - Register your organisation
 - Link HPOS in PRODA
 - Request NASH site certificate
 - **Or [link your CSP in HPOS](#)**
- Setup & maintenance of organisation members and delegations
- Learning and the digital literacy of staff
